Prior to grant funding being secured,
ThunderCon organizers decided to reduce
uncertainty and limit additional spending.
Overall ticket sales were slightly below
budgeted targets of \$35,000, but cost
controls in other areas will allow
ThunderCon to make some smaller
capital expenditures and allocate funds to
operating costs with the surplus that was
generated through successful grant
applications. 2023's budget will
incorporate available funds to increase the
overall event budget.

Governing Council (Board of Directors)

ThunderCon Board of Directors functions a little differently than most non-profit organizations. Directors serve as both the governance and executive committees and are responsible for the overall management and direction of the organization as well as daily operations. Directors are elected annually and provided with their mandate to govern by paid members



of the organization who entrust the appointments of key management and volunteer positions to the decisions of the board.
